Accreditation 2023: The role of medical staff

Accreditation Canada surveyors will be visiting the teams selected to represent VCH from November 19 to 24, 2023. They will conduct tracers to observe and interact with staff, volunteers, patients and their families to gather evidence about the quality and safety of care we provide. They assess compliance to the standards through one-on-one interviews with care teams, patients and families, direct observation of care and other unit activities and documentation review.

Medical staff play an important role in the Accreditation process. They can help by being aware of the team/unit's tracer dates and the program's key improvement initiatives and action plans, providing input in selecting patient charts for the tracer, and being available when needed during the site visit to interact with the surveyor. 

Don't take the bait! Phishing attack education for medical staff Phishing emails are sent by criminals trying to trick you into giving away private information like passwords or patient information. Phishing attacks often have obvious signs that can help you identify them, which can include a greeting that doesn't use your name, an

unexpected attachment, mistakes in spelling or grammar, and messages that create a sense of urgency. Be especially cautious of emails requesting private information, directing you to unknown websites or asking for immediate actions. These could be attempts to access sensitive patient data or other confidential information. Always double-check the sender's email address and any links included
